**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF  
POTTAWATOMIE COUNTY, KANSAS, PURSUANT TO K.S.A. 19-204  
PROVIDING FOR REARRANGEMENT OF COMMISSIONER DISTRICTS**

**WHEREAS**, the Board of County Commissioners of Pottawatomie County, Kansas, meeting in regular session, subsequent to the reorganization session of said Board, and as soon thereafter as possible, find that the Commissioners Districts of Pottawatomie County, Kansas, are presently as compact and equal in population as possible.

**AND WHEREAS**, the Board of County Commissioners of Pottawatomie County, Kansas, recognize the duty imposed upon them by law to reapportion such Commissioner Districts into compact and as nearly equal in population as possible.

**AND WHEREAS**, the Board of County Commissioners of Pottawatomie County, Kansas, believes the Commissioner Districts to be as compact and equal in population as possible, at this time, and therefore,

**RESOLVES**, that the Pottawatomie County commissioner Districts be established and remain as follows:

**COMMISSIONER DISTRICT NO. 1**, comprised of the following Townships of Pottawatomie County, Kansas:

GREEN TOWNSHIP  
POTTAWATOMIE TOWNSHIP  
ROCK CREEK TOWNSHIP  
SHANNON TOWNSHIP  
ST. GEORGE TOWNSHIP  
MANHATTAN CITY (Within the boundaries of Pottawatomie County)**

**COMMISSIONER DISTRICT NO. 2**, comprised of the following Townships of Pottawatomie County, Kansas:

**LOUISVILLE TOWNSHIP  
SHERMAN TOWNSHIP  
UNION TOWNSHIP  
WAMEGO TOWNSHIP  
WAMEGO CITY**

**COMMISSIONER DISTRICT NO. 3**, comprised of the following Townships of Pottawatomie County, Kansas:
